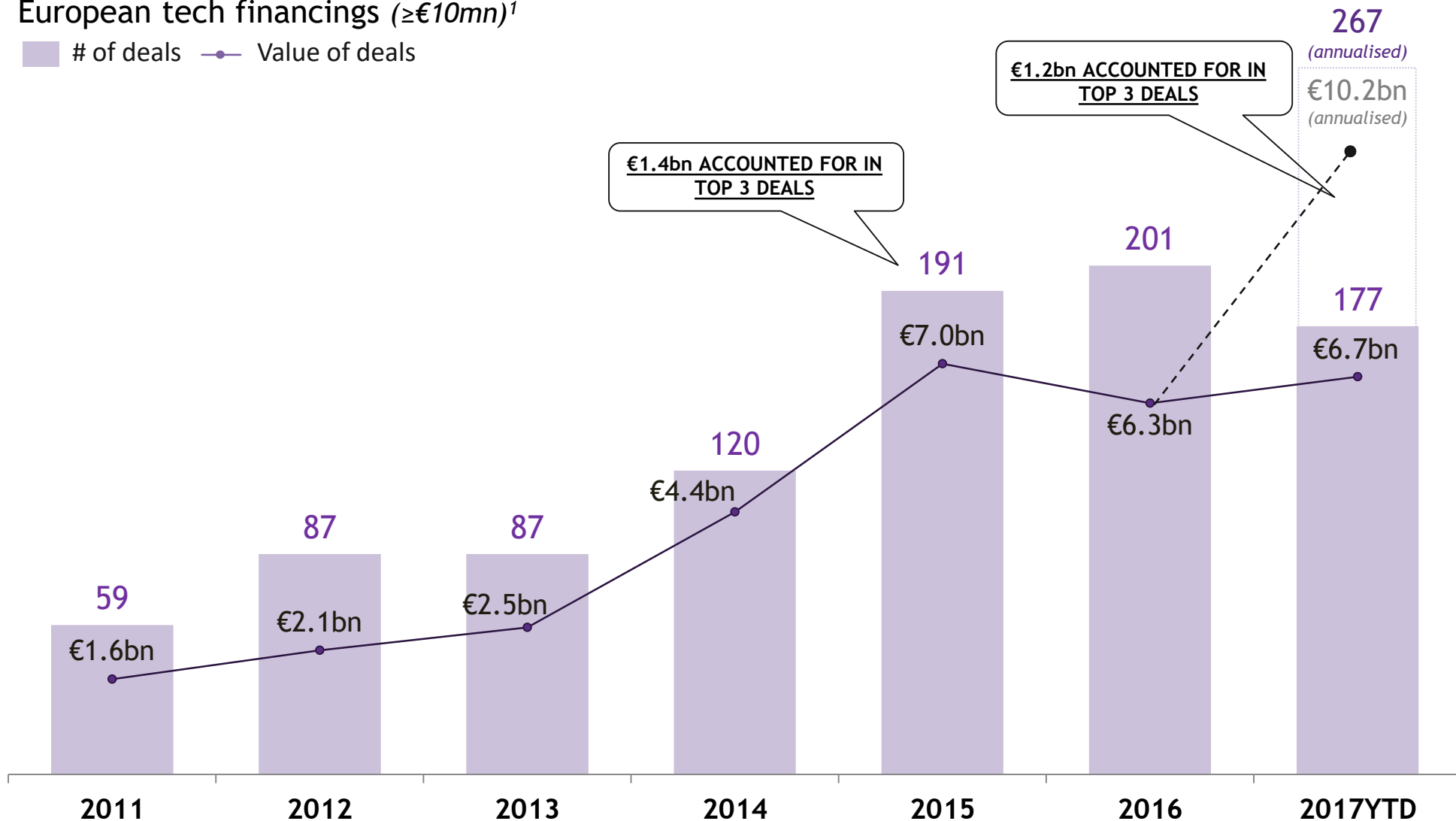

■ # of deals — Value of deals













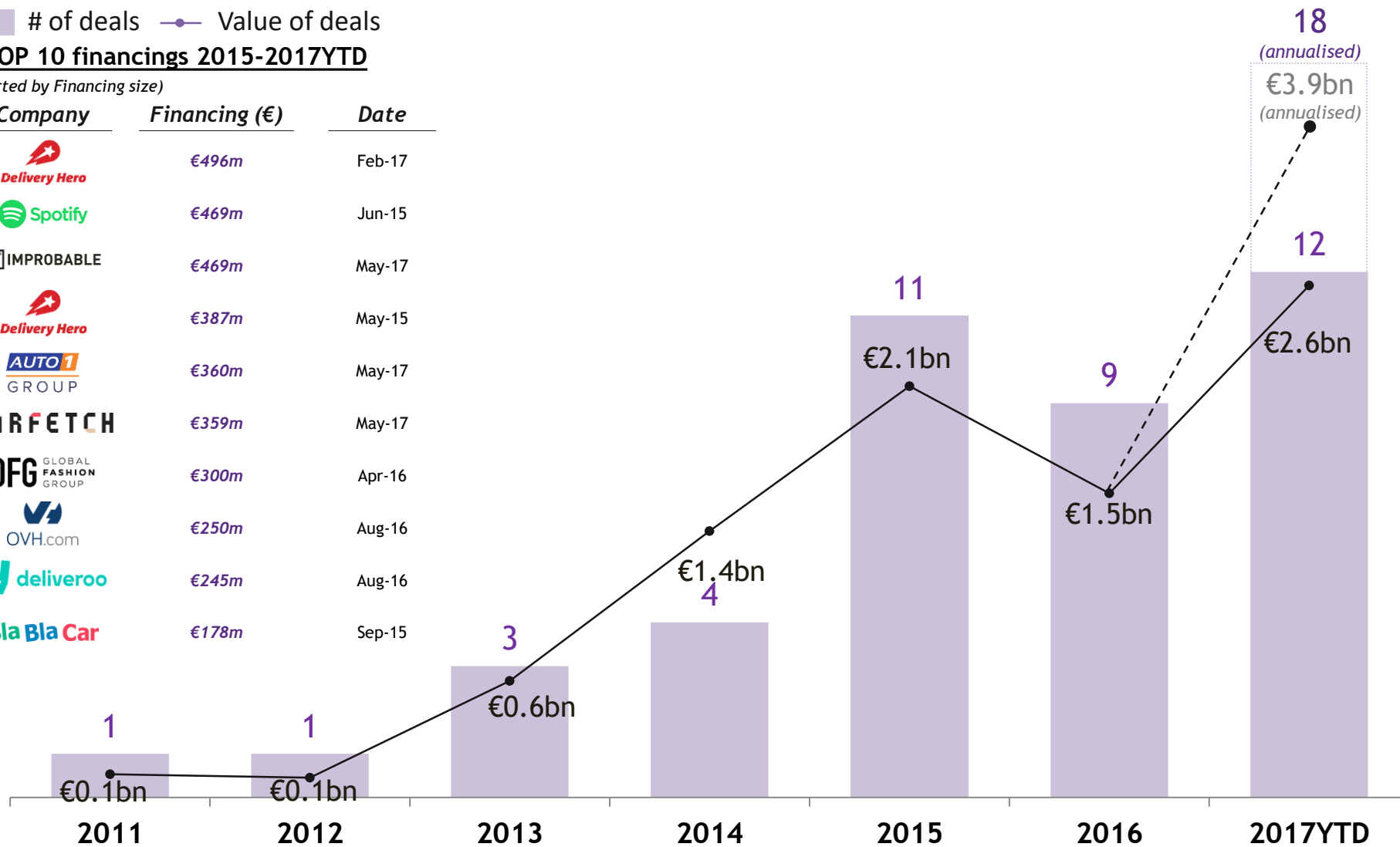
Mega-deals (≥€100mn) have picked-up again strongly

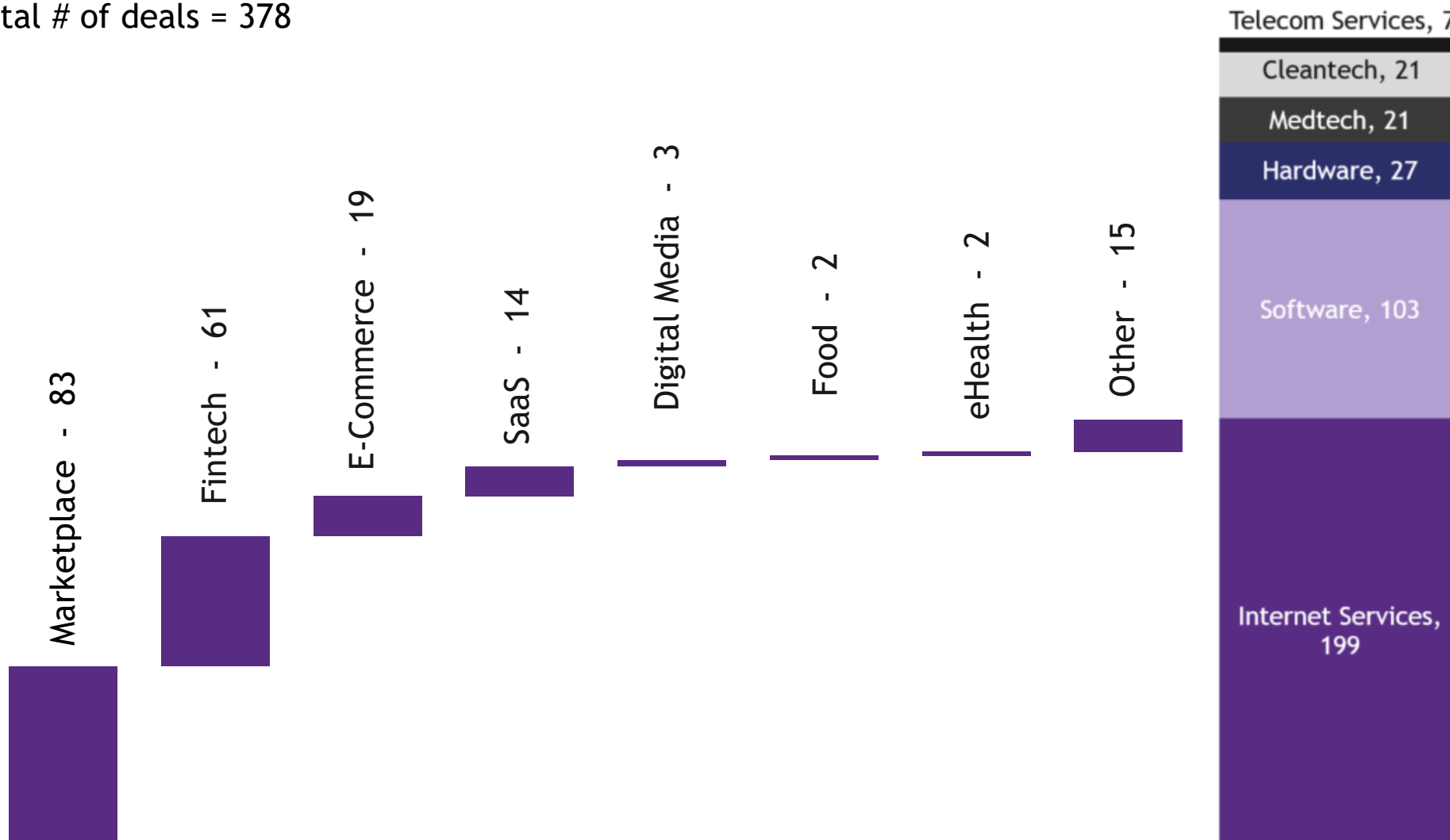

of European tech financings by **sector** (≥€10mn)¹

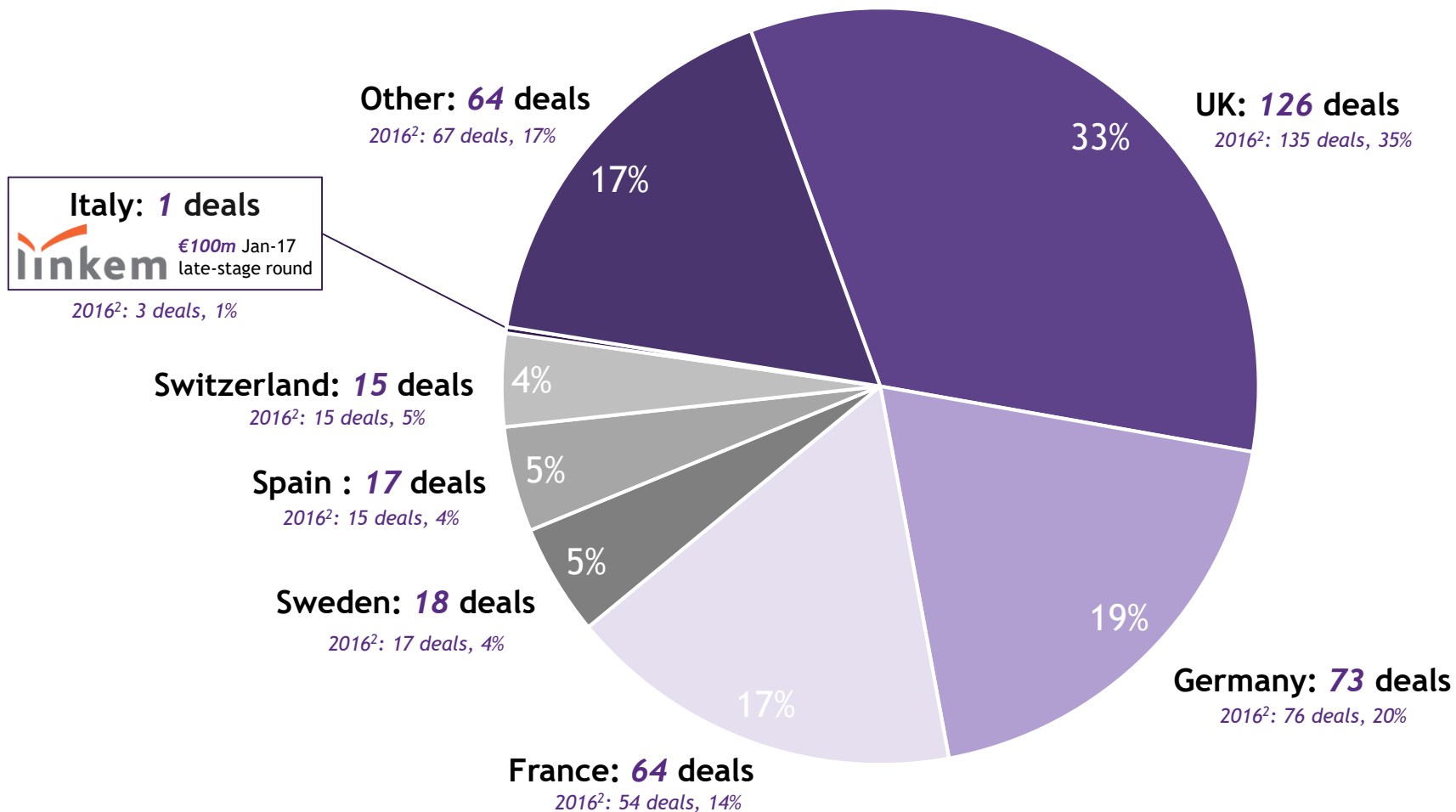

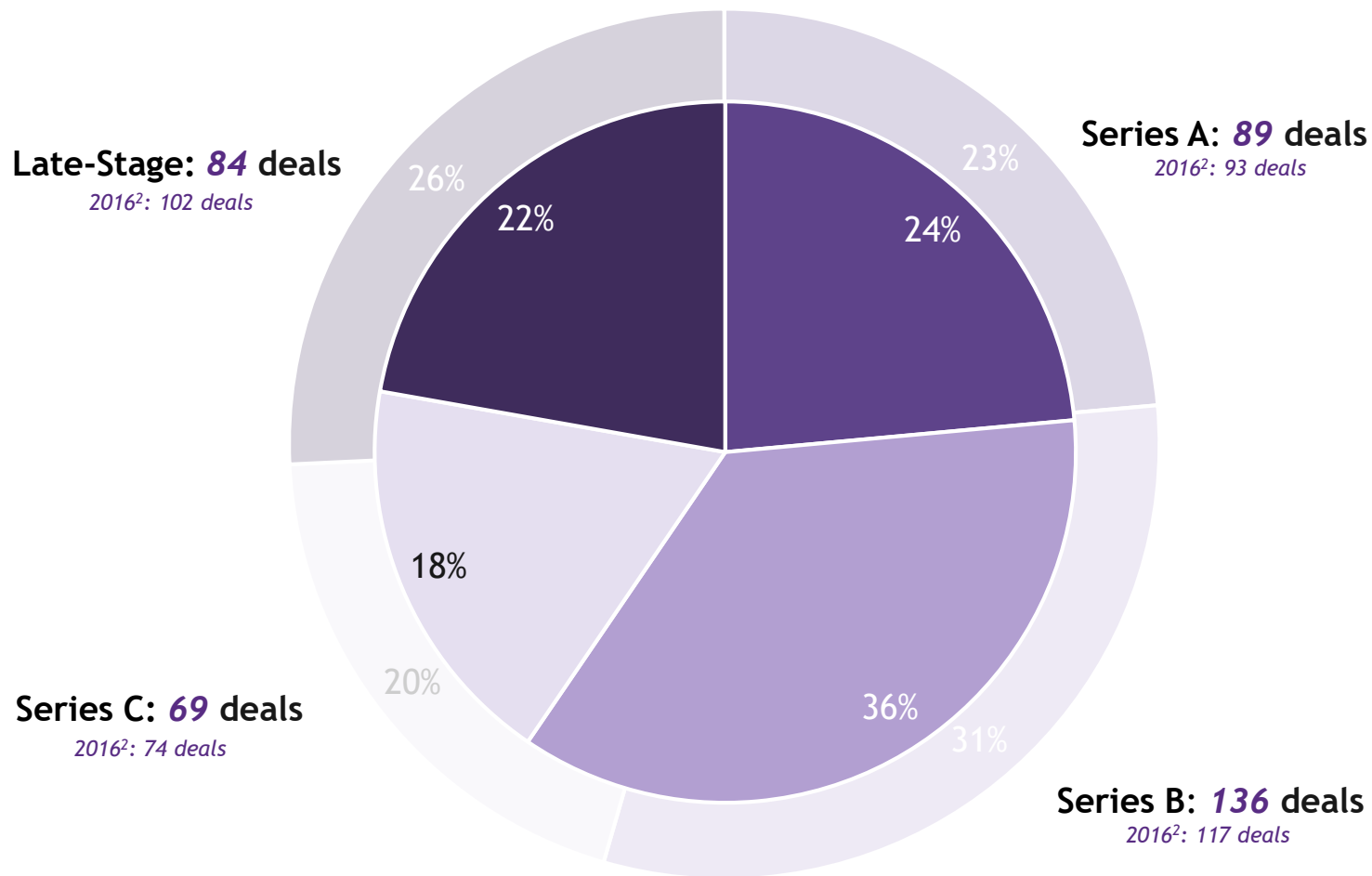
